SUPERINTENDENT'S REPORT

- Mr. Earley turned the floor over to Mr. Kevin Dunn, Principal of Williamsburg Elementary School. Mr. Dunn proudly introduced Easton McQueen. This extraordinary Wildcat won the WES 2023 Spelling Bee, beating two past WES champions, then qualified for the WCPO Scripts Southwest Ohio Regional Spelling Bee competition. This was no easy feat. After winning the district competition Easton underwent an extensive testing process in order to be selected as 1 of 25 regional competitors. Furthermore, Easton qualified as a fifth grader, competing mostly against 7th and 8th graders! While he was disappointed he didn't win the regional competition, Easton told the Board he was grateful for the experience. He really appreciated the strong support from his teachers and peers, especially the spirited send-off he got at Friday dismissal the day before the competition. The Board congratulated Easton on a job well done and thanked him for being an exceptional ambassador for our district.

 - Mr. Earley also congratulated the 22 new inductees to the National Honor Society.
 This year's class included twenty juniors and two seniors. We also congratulate and

REPORT FROM U.S. GRANT CAREER CENTER

Williamsburg Board Representative, Beth McManus, highlighted several items of business from U.S. Grant Career Center, including:

- Bethel is the current district with two representatives on Grant Board.
- As an extension of the highly successful "Grant Gives Back" community service program, 24 students will be traveling to Hazard, KY, next month on an extended service learning project utilizing their career tech skills to support this underserved community.
- At their March business meeting the Grant Board gave approval for the Grant Superintendent to create a "Career Based Intervention Program" to help at-risk students complete their career tech education to graduate and secure their certifications.
- Mrs. McManus highlighted the Grant enrollment of Williamsburg students, with Allied Health, Welding, Vet Science, and Early Childhood being the most popular programs.
- Williamsburg also received a \$5,000 Middle School Career Development Grant to help inform MS students and parents learn about the strong opportunities in career tech.
- Last, Mrs. McManus announced Grant CC was one of only two districts in Clermont County to receive the Auditor of State Award for a spotless state financial audit.

TREASURER'S REPORT

Mr. Wells highlighted matters impacting the district's finances, including:

- Board members are encouraged to learn about HB1. If passed, this bill would have a
 substantial impact on public schools. It has the potential to reverse the gains made from the
 Cupp-Patterson Fair School Funding Plan (FSFP). Board members should do their research
 regarding HB1 and contact our state legislators to share their concerns.
- Speaking of FSFP, statehouse negotiations are underway for the next biennial budget. The
 first pass projections have WLSD seeing a hypothetical increase, but final budget isn't due
 to the governor's desk until June. We will take a conservative approach on state foundation
 in the May Five Year Forecast, keeping it flat. Once the budget is signed and implemented
 the changes will be reflected in the NOV 5YF.
- Speaking of the 5YF, we have initiated kickoff meetings for the May forecast construction.
- In the past 45 days the district has received almost \$2.2M in first half TY2022 real estate taxes. This includes both Clermont and Brown Counties.
- Monday afternoon, prior to the Board meeting, we completed an ODE Desk Audit for IDEA Part B. This was a random audit conducted on approximately 10% of districts annually. Special thanks to Tina Reichart for all her efforts to collect the extensive program documentation required for the audit, in addition to our financial records. We were well prepared for the audit and passed with flying colors.
- In the past week, both staff members of the Treasurer's Office have participated in job shadow opportunities at Goshen and Norwood. These professional development days allowed them to collaborate with their highly proficient peers and learn best practice. This learning will help drive continuous improvement in our district.
