SUPERINTENDENT'S REPORT

Mr. Earley gave the floor to Elementary Principal, Kevin Dunn, to present this month's Moment of Excellence. First, Mr. Dunn recognized the Williamsburg Elementary School Spelling Bee champion, Izzy Collins. Izzy was also the 2024 School Champion. Mr. Dunn credits her extraordinary work ethic as the secret to her success.

Mr. Dunn then recognized Izzy, along with classmates Everly Henning and Quentin Maupin for their extraordinary work in the 5th Grade STEM/Gifted Program. They recently completed a real-world project-based learning experience in Mrs. Dean's STEM/Gifted class to design playgrounds for the new elementary school. The students did extensive research using industry articles and building code. They also collected survey data from 4th and 5th grade students, as well as teachers, to determine preferred features and equipment. After completing their due diligence, the students constructed site models incorporating their findings. The students reviewed their models with the Board and audience. Everyone was impressed with the thoughtfulness of design, especially their inclusive features to serve all students. The future of Williamsburg is bright with students like Izzy, Everly, and Quentin leading the way!

Mr. Earley then reviewed news from around the district, including:

- Mr. Earley distributed a winter sports wrap-up from Athletic Director, Jason Moberly. Once
 again Williamsburg had outstanding team and individual accomplishments. Congratulations
 to all our league champions and runner-ups, and those receiving all-league/district honors.
- This week we also honor the legendary Burg athletes of the past by inducting seven Wildcat alumni into the Athletic Hall of Fame. The Induction Gala is this Friday evening.
- This Friday is also the end of quarter. State testing will kick off April 9.
- This Thursday is the WES Fine Arts Night. Everyone is encouraged to attend this
 exceptional event showcasing the talent and creativity of our elementary students.
- Thursday is also the departure date for 8th grade trip to Washington DC. Our thanks to Mr.
 Dunn and all the chaperones for leading this great learning experience.
- Spring break is March 24-28.
- Finally, everyone is encouraged to attend the WES Carnival, April 12.

REPORT FROM U.S. GRANT CAREER CENTER

Mr. Maklem reported the last Grant BOE meeting included two very informative presentations regarding GCC's Digital Creation and Satellite programs. The early metrics are very encouraging. Brown-Clermont Adult Career Campus (BCACC) is also looking to add programs for HVAC and EMT training.

TREASURER'S REPORT

Mr. Wells reviewed financial highlights of the district, including:

- The new state biennial budget continues to dominate public education news. The current proposal reduces spending on public education and increases public school dollars channeled to private schools. It also uses FY22 cost inputs that lags inflation. Two separate funding simulations show our district receiving no additional state support or actually taking a \$20K net loss over the two fiscal years. To complicate matters further, there are several bills under consideration that could reduce real estate tax revenues as well. We encourage our staff, parents, and community to keep updated on these biennial budget proposals and contact their state representative and senator to make their voices heard.
- The district received our first advance from the County Auditor in late February for \$2.1M, over 45% of our total tax revenue for the fiscal year. This is much later than normal but delays are being reported statewide as homeowners grapple with higher home values and subsequent taxes. Such delays reinforce the importance of having adequate operating capital in reserve.
- We have also received our first semester reimbursement from Grant Career Center for our innovative VM CTE program, totaling over \$48K. That's almost 2/3 of what we originally projected to make in the entire first year of the program.
- Finally, we have officially wrapped up our State Audit for fiscal year ending June 30, 2024.
 The district received a clean bill of health financially and got high marks for strong internal controls. Once finalized the audit report is distributed to key stakeholders for annual compliance reporting, including the financing on the new elementary school.
